# School news

#### Uniform

Last week I wrote that we had noticed a few items of non-uniform, especially on the lower half (trousers/skirts). This has really improved this week so thank you, but there are still a very small number of children wearing incorrect clothes, shoes or PE kit to school. School items, including PE kits, should all be <u>plain</u> with the exception of school logo items. Please make sure long hair is tied back for school. We will now be contacting individual parents to remind them if we notice that children are not dressed in the proper uniform or PE kit. If you are having a problem with uniform, it is important that you talk to us. There are funds available to the school via Chippenham Borough Lands Charity to support people who may be struggling financially, so if cost of living is affecting your ability to provide proper school uniform, we may be able to help; this can be done very discreetly and we do not need to report any names of recipients to CBLC.

Equally, if something has gone wrong with getting hold of uniform when your child has outgrown an item, please let us know about any temporary delays so we can understand what is going on.

Please make sure all items are clearly named – one blue logo jumper looks exactly the same as everyone else's jumper! There is a reminder of the full uniform policy at the end of this newsletter.

#### Attendance / absence system changes

Thank you so much for embracing our new absence reporting system so quickly - hopefully the new electronic systems are quicker and easier for parents, as well as streamlining things for us in school. Miss Wakeham has been contacting parents when children are absent, as per our new procedures, and this will continue as set out in the letter I sent out about attendance last Friday.

Instead of phoning in, there are two electronic options for reporting a child's absence:

- Via the school website <u>www.frogwell.co.uk</u>. Go to the 'Parents' tab and choose 'REPORT AN ABSENCE'. This will take you directly to a simple online form where you will fill in your child's name, class, the date and give the reason for the absence.
- 2) Via email to a new dedicated email address <u>attendance@frogwell.wilts.sch.uk</u>. This address can also be found on the same website page as the online form link above, in case you forget it!

#### **Parents' Evenings**

Parents' Evenings will be held on Monday 10<sup>th</sup> October (15.30-17.30) and Thursday 13<sup>th</sup> October (16.30-18.30), and then again in the Spring. These will be face-to-face short appointments, but you will be able to request a Teams or phone appointment if you cannot attend in person. These meetings will be focused mainly on how your child has settled into their new class, how they are getting on and any ways we need you to support at home. Online booking information will follow from the office in due course.

#### Morning snack reminders

Please can we remind parents that snacks brought in for morning break times must be either fruit / veg or a basic cereal bar. Biscuits, crisps, sweets, chocolate, popcorn, sausages, winders, roll-ups, dunkers etc are <u>not</u> allowed and we will not let children eat them if they bring them. Water bottles for outside lunch time should contain plain water only. Juice / squash is fine with a packed lunch.

#### **Harvest collection**

We will be holding our usual Harvest assembly later this term and would like to ask for donations for Doorway, the local charity that supports people who are homeless or in vulnerable housing situations. There is a flyer at the end of this letter showing the items they need and those which they cannot accept. If you wish to donate, please send items in to school in the <u>week of 26<sup>th</sup> September</u> (not before or after please).

# <u>Safeguarding</u>

'Safeguarding' and 'Child Protection' are terms you may hear used a lot in schools and in the media, but what do they actually mean?

**Safeguarding** refers to the whole umbrella of processes we use to protect all children and to provide safe and effective care. This includes all the procedures designed to prevent harm to a child, including:

- Being alert to signs and symptoms of abuse or neglect and noticing changes in children's behaviour or presentation that suggests they may need support
- Carrying out risk assessments for activities and trips to ensure they are planned as safely as possible
- Health and safety checks to make sure the school environment is as safe as possible
- Following strict 'Safer Recruitment' procedures to make sure all staff and volunteers are suitable to work with children
- Helping children learn how to be safe online
- Teaching children about road safety, stranger danger, healthy lifestyles, safe and healthy relationships etc
- Making sure children have people they can talk to at school about worries, plus things like 'worry boxes' to make it easier to signal if something is wrong
- Checking where children are if they are not at school
- Improving children's attendance and punctuality at school because this impacts on their overall wellbeing
- Having pastoral systems to support children, such as our Thrive programme.

**Child Protection** is part of the bigger safeguarding process, protecting specific individual children identified as suffering or likely to suffer significant harm. This includes the child protection procedures which detail how to respond to concerns about a child. The school has a legal obligation to report any concerns about a child if they feel that a child may be subject to neglect or physical, emotional or sexual abuse. This includes concerns about the child in the home and the wider environment. If we have such a concern, we will contact the Wiltshire Multi-Agency Safeguarding Hub (MASH) to ensure that concerns are dealt with in a manner which puts the well-being of the child as priority. We appreciate that parents and carers can find these events very worrying and upsetting. Whenever possible, we will discuss concerns with parents before seeking advice to safeguard a child; however, there are some circumstances when we are obliged to seek support from a professional trained to investigate safeguarding concerns.

Who is responsible for Safeguarding in school? The short answer is... EVERYONE! <u>All staff and volunteers</u> are responsible for being alert to the signs of neglect and abuse and for reporting them to the Safeguarding Lead Team. All school staff have a responsibility to provide a safe environment in which children can learn. All staff receive safeguarding training and regular safeguarding updates in areas such as online safety and the Prevent duty. The <u>Safeguarding Lead</u> and <u>Deputy Safeguarding Lead</u> have additional training so that they can carry out their responsibilities effectively. The Safeguarding Leads give advice to staff and also liaise closely with other services such as children's social care.

#### Frogwell's Safeguarding Lead Team is:





**Ofsted (November 2021) said...**The arrangements for safeguarding are **effective.** Safeguarding records and practice are reviewed thoroughly. Leaders carry out the necessary safeguarding checks before staff begin working at the school. Staff and volunteers receive appropriate safeguarding training. They know how to report concerns about a pupil's safety and well-being. Safeguarding referrals to external agencies are made in a timely manner. Leaders escalate concerns if they believe they have not received an appropriate response from external agencies. Pupils are taught how to keep themselves safe. Leaders have plans in place to help develop further pupils' understanding of bullying, including cyber-bullying.

#### **Reminders**

Parents and Carers are asked <u>not</u> to make any form of video or audio recordings or take photographs within the school grounds, other than those approved at official school events such as concerts.

Please remember bikes and scooters must not be ridden on the playground.

Children must not play on the climbing/balancing equipment before or after school.

Please do not allow children to be on the grassy bank behind the car parking bays for any reason at any time.

Gates are locked at 08:55 in the morning so parents can leave the site but school officially starts at **08:50** so arrivals after that time will be marked as late.

Please do not smoke around the school entrance areas.

#### Dogs on school site

Please remember that dogs are not permitted on the school site, except assistance dogs. This includes dogs being carried as well as those walking.

We have our own official visiting dog, Roko, who is risk assessed, carefully planned for and insured but other dogs may not enter the site. This includes the area around the car park and along the front of the school, not just in the playground. We also cannot have dogs tied up outside so any dog owners will need to make other arrangements for their pets during school drop off and pick up times.

### **Online safety information**

The internet has transformed the ability to access content. Many apps that children use are dependent on user-generated content which can encourage freedom of expression, imagination and creativity. However, due to the sheer volume uploaded every day, it can be difficult for platforms to regulate and moderate everything, which means that disturbing or distressing images, videos or audio clips can slip through the net. That's why we've shared this guide from National Online Safety to provide parents and carers with some useful tips on keeping children safe online.

In the guide, you'll find tips on a number of potential risks such as age-inappropriate content, privacy issues and mental health.



# School uniform policy (including rules on jewellery etc)

At Frogwell Primary School we believe that school uniform is important for the following reasons:

- it helps promotes a sense of pride in the school and a feeling of belonging
- it is practical and distinctive
- it helps us quickly and easily identify Frogwell children when out on tripe etc
- it is not distracting in class
- it helps make children feel equal to one another in terms of appearance

All children are expected to wear the school uniform.

It is essential that all items of clothing are clearly named as matching lost items of un-named identical clothing to the owner is very difficult and a waste of valuable teaching time for staff. School logo jumpers and other items can be purchased from Scholars in Chippenham town centre. Plain items of uniform are readily available in supermarkets.

## Clothing

- Royal blue school sweatshirt or cardigan (plain or with school logo)
- <u>Grey</u> skirt, trousers or smart school shorts
- Pale blue polo shirt / cotton shirt (optional school logo polos are available to order via our online shop)
- Blue checked summer dress
- Black, grey or white socks or tights

### Shoes:

- Sensible flat <u>black</u> school shoes or <u>smart plain black</u> trainers (not boots please). All shoes should be <u>plain</u> black, without any white stripes etc.
- Sturdy sandals are permitted in the summer but these must be securely attached to the feet and suitable for active play (no flip-flops, sliders or similar).

## PE Kit:

- <u>Plain</u> black / navy shorts, <u>plain</u> white t-shirt (optional school logo PE tops are available to order via our online shop)
- Daps for indoor PE
- Trainers for outdoor PE
- <u>Plain</u> black / navy joggers and a <u>plain</u> black / blue sweatshirt or 'hoodie' may be worn for cold weather outdoor PE in the winter.
- Please remember to pack socks for those who wear tights with their normal school clothes!

## Swimming kit:

- Sensible one-piece swimming costume for girls (no bikinis or tankinis please)
- Sensible trunks / fitted shorts for boys (no baggy shorts please)
- Swimming hats are strongly encouraged by school and the swimming pool
- Towel

### Hair, make-up, jewellery etc

- Children should not come to school with 'fashion' hairstyles including dyed hair colours, mohicans or tram lines / shaved patterns.
- Long hair should be tied back.
- Hair accessories should be kept simple and small (e.g. no 'JoJo bows' or fancy hairbands).
- Make-up and nail varnish are not to be worn to school. False / acrylic nails are not allowed
- The only jewellery permitted is a watch and one pair of small stud earrings (earrings must be removed or covered for PE for safety reasons). Hoop earrings are not suitable for school due to the risk of them being caught and pulled during active play or in busy environments.
- Temporary tattoos are not to be worn to school.
- Parents are responsible for making sure that any weekend or school holiday makeup etc is completely removed before children come back to school. This includes where children have worn make-up etc as part of theatrical or dance performances out of school.

We hope children are proud of their school uniform and that it makes getting ready for school easier for parents. We appreciate parents supporting us, and their child, by ensuring they are dressed appropriately for school. This is a good habit for children to get into for their future at secondary school and in employment.
